Additional information to get to meeting on Occidental campus

Parking: Enter the college via the Alumni Ave x Campus Rd intersection. This is the main entrance. Then, immediately to your right is a parking lot. Anyone can park there for free after [5 pm](#). If you're familiar with the campus, you can drive a little further to park in the lot right behind the library.

Galarza Room: You will walk up a short flight of stairs to enter the main and only entrance of the library. If you park in the parking next to the main entrance, you would walk past the fountain, turn right into the quad filled with oak trees and head to the library. When you enter the library, walk in and go towards the left to the hallway furthest away from the entrance - i.e. closest to the elevator and bathroom. The Galarza Room will be right there.
