Are a 501 3C Non profit. No booze on display. Only when an event prior to a show or shortly after. Board taking Spanish. East/west players. Security to ensure safety. Transfer of license, don’t know how it works.

**Public Comment: Gemma Marquez** asks about outreach to the community especially about parking. Spirit of community and bringing communities and art. Students going into a place with alcohol. Chamber of Commerce on York Bl. Promises to keep it clean, but always a bunch of lies. Spanish plays? Bilingual foundation of theater? Will we see that? Law enforcement don’t have enough units can’t be everywhere? Will have security?

guards? **Rose Serna** – One thing this community has been fighting for is to stop giving out these alcohol licenses. I think it is a nice idea your theater. Don't understand why you feel the need to sell that. Not to profit off sale of alcohol. Already have funding for 3 years. Like space for youth, need to model what we want our youth to be exposed to. Substance abuse on rise. Lots of homes, need to do outreach first. Drugs and alcohol create unsafe situations. **Rosa Rivas:** To ladies who spoke before me same concerns. Down Av 54 have the High School. Concerned about alcohol. Like Rose says already saturated. Parking but you already explained that. Ans. *Community oversaturated are correct. Gary at Bussards might find parking there. Alcohol open for community projects. Won't serve Alcohol until 7 p.m. when have 99 people coming to show it's helpful. Query making with you. Hoping it will be part of our financial structure. Like to add 9 seats at café table.* **Tani Kaye:** Like what Tamilyn said about liquor only during the hours that there are shows. Will liquor license show what hours will be in service. **Amy Ludwig:** Bootleg, food, support my neighbors. *Allison DeLaCruz bring in need them to be fed. Worked with kids in Little Tokyo Pasadena, front doors closed at night. Don't want to have noise issues.* **Sylva Blackstone:** I live the closest. Will people be crossing the street to reach venue? Fire engine goes on York Blvd. Cars pretty much packed in there. *Will work on access to the location. You are perfectly right to ask for this, because you have been disappointed. Cross light on Av 54<sup>th</sup>. Tell them don't park here. Screeching cars I heard. Not something I want to bring into a neighborhood. Will ensure these concerns are addressed in design.*

**Rick:** Would like to hear from neighbors – Carmela Gomes. Hear to work out something with you. Like to hear from CD 14. Not a great Chamber of Commerce. Full Line – Reason is to come back is very expensive. *But if have a Black Tie. Ask at onset. Interested to coming back to talk with you.*

**Emma Howard:** Will not make a decision until when we hear from the neighbors. Do note over concentration of alcohol licenses. Proliferation of alcohol sales, peripheral uses. Things that are bigger picture issues. This time neutral because we are listening. Option for bear wine/ special events. Hours very consciously.

**Theresa Elongorria:** Very similar to the Lyric in Silverlake. Don't know if anyone else familiar. Heavy residential. Enjoyed part of the community in their neighborhood. Speak to heritage and history of Theater Row in HP. Huge part of community. Nice to see it be a part of HP. Daniel spoke that want to reinvest in community. Come back to another meeting. With and without alcohol. Beer and wine sales a big part of .

**Liz Strong:** Have been to these. Understand concerns of neighbors on neighboring streets. Arts community might make good neighbors with you. Allow HS students to have experience. Don't see it being much of a problem.

**Clara Solis:** Who is on the board? Bilingual Theater. Response: *Bilingual theater. Haven't started looking at plays. Reflects the neighborhood. A voice that is needed in theater. Long predominance of white theater. Looking forward to promoting that. Community will look better for it. Board no public announcement yet. Have people involved. Jessica Hansen. Allison Delacruz. **Rosa Rivas:** Project is way too big for that little corner. All neighbors in opposition. Architecture doesn’t match our community. She wants to build 33 units. Ten or 15 units better there.

**Sylva Blackstone:** Interested to see where councilman’s comments are if they are being submitted. Been studying HPOZ document. Concerns with protecting the community. General plan. Does not match up with things in the community plan. Several things not in compliance. So far off. So doesn’t work. Putting a baby in a bog down. So wrong so obvious.

**Gemma Marquez:** Totally opposed. Too big HP already did its density. Traffic too much. Say this is housing that we need. Could only speak to aesthetics. Only speaking to affordability. \$3 a square foot. Largest unit 1700. \$5100. Which community can afford this. All about profit.

**Tani Kaye:** Anything to get more people to HPOZ meeting next time.

**Rose Serna:** Clear that architect and developer did not take into concern size of development. Repair harm they have done to our community in the past. Shouldn’t get these exemptions. Not fair trade for 3 units. Height density and See CD 14 step in and advocate for this community.

**Amy Ludwig:** Echo what Rose said,. They have their vision for this. Need a traffic study for this. Cars entering from Av. 64. Need to see a traffic city.

**Suzanne Gero:** Same shape looking like an office building. Fine in other 95% of city but not in HPOZ. Other buildings large, different porches at different levels. Rest is residential. Craftsman to that design.

**Rick Marquez:** Have a concern – things that come before HPOZ. They were limiting to jurisdiction of the body and scope. Problem I have when reverse architecture. Designed from the outside in. Inside out maximum sq footage. When that is under consideration. That reputation of developer and design. Not true not a design development. Not designed for architecture value. Very selective on what they want to hear from community. Square footage. Design based on overall profit. Should be given right to speak freely.
